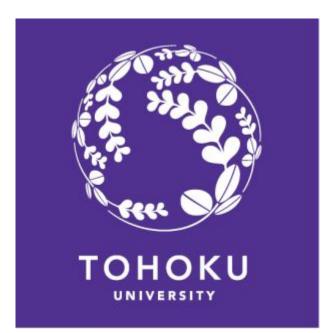

#### Educational Management and Leadership Program (EMLP)

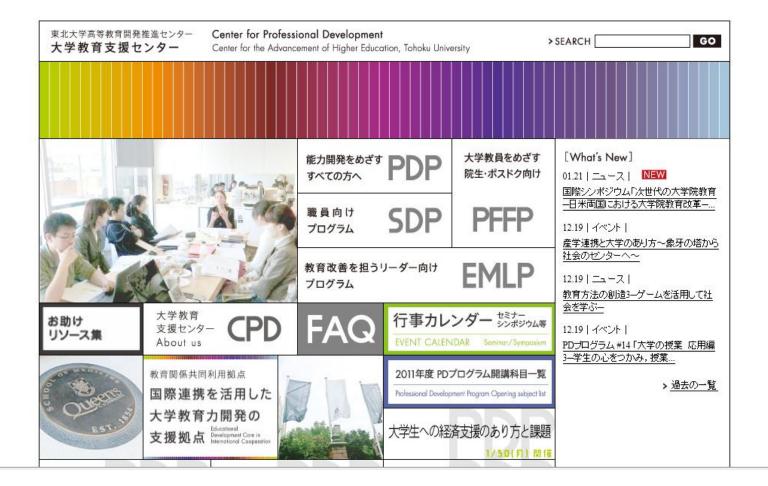

### The Japanese Context

#### • Deregulation and QA after the 1990s

1991	Generalization of the Standards of the Establishment of University Stipulation of self-evaluation by universities in the SEU (not mandatory)
1998	University Council Report 'University Visions in the 21th Century and Future Reform Policies: For Creating Individualized Universities in a Competitive Environment'
1999	Stipulation of self-evaluation by universities (mandatory) and external evaluation (not mandatory) in the SEU
2002	Central Education Council Report 'Building a New System for University Quality Assurance', Amendment of the School Education Law
2004	Start of certified evaluation system, Incorporatization of national universities
2005	Central Education Council Report 'Future Image of Our Higher Education'
2008	Central Education Council Report 'Toward the Establishment of Undergraduate Education'
2011	Start of the Second cycle of certified evaluation system

## The Japanese Context

#### Increased Interest in Internal QA

- Second cycle of Certified Evaluation (Nisho-Hyoka) started in 2011
- More emphasis on Internal Quality Assurance in the second cycle
- Disclosure of educational Information and data by each HEI from 2011
- Recent interest in institutional research (IR)
- How to manage various educational improvement activities in a more consistent way

# What is a more robust Internal Quality Assurance?

#### ENQA's standards for internal QA

- 1. Policy and procedures for quality assurance
- 2. Approval, monitoring and periodic review of programmes and awards
- 3. Assessment of students
- 4. Quality assurance of teaching staff
- 5. Learning resources and student support
- 6. Information systems
- 7. Public information
